Sealed quotations are invited for the following items in the College. The details of the same are as under:-

S.No.	Description of Work	Rate Rs.
1	Making of arched/taper roof shed for a couple of water-cooler installed in front of quadrangle area of 10'X15' size by fabricating M.S. structure supported on 04 nos. of 2 inch Square iron pipe of 14 gauge & roof structure with arched/taper 1.5 inch square iron pipe 14 gauge. Purlins to be made of 1.5 inch square iron pipe of 14 gauge forming of 2.5X2.5 Ft grid. The shed should be covered with 3 mm thick fiber sheet fixed with nuts & bolts and rubber washer to stop leakage including painting with synthetic enamel paint etc. complete. The foundation of the post of the structure should be cement concrete 1:2:4 of size 1X1X1 ft. The height of the structure above the ground would be 10/9 ft.	
2	Making of arched roof shed for R.O. Plant on the roof over an area of 8'X10' Ft. size by fabricating M.S. structure supported on 04 nos. of 2 inch Square iron pipe of 14 gauge & roof structure with arched 1.5 inch square iron pipe 14 gauge. Purlins to be made of 1.5 inch square pipe of 14 gauge forming of 2X2 Ft grid. The shed should be covered with 3 mm thick fiber sheet fixed with nut & bolts and rubber washer to stop leakage including painting with synthetic enamel paint etc. complete. The foundation of the post of the structure should be cement concrete 1:2:4 of size 1X1X1 ft. above the roof. The height of the structure above the roof label would be 08 ft. Note: Required Two numbers, one for new R.O. Plant and other for Canteen R.O. Plant.	
	Making of Taper shed above the R.O. drinking water over an area of 4'X11' Ft. size by fabricating M.S. structure supported on 02 nos. of 2 inch Square iron pipe of 14 gauge & roof structure with 1.5 inch square pipe 14 gauge. Purlins to be made of 1.5 inch square pipe of 14 gauge forming of 2X2 Ft grid. The shed should be covered with 3 mm thick fiber sheet fixed with nuts & bolts and rubber washer to stop leakage including painting with synthetic enamel paint etc. complete. The foundation of the post of the structure should be cement concrete 1:2:4 of size 1X1X1 ft. above the ground base. The height of the structure parallel of the roof label and down post would be 08 ft.

4. Quotation should reach to Principal, Motilal Nehru College, Benito Juarez Marg, New Delhi-110021 through Registered/Speed post or dropped in the Box available in the Office latest by **22.06.2018 up to 1.00 p.m.. & the same will be open on 22.06.2018 at 2.00 p.m.**
5. The bidders are strictly required to attach a copy of GST/VAT registration certificate of the firm, with PAN number of the firm/owner otherwise bid/quotation will be deemed rejected.
6. In complete/conditional quotation will not be accepted.
7. On inspection, if the material or workmanship is not found as per the specification or any item is found damaged the same shall be rejected. In case of rejection of the materials, no payment will be made for the rejection item.
