1. Written apology by the Respondent in front of the Complainant in presence of executive authority of H.E.I.
2. Written assurance by the Respondent not to indulge in any such behavior in future, if it is repeated then strict departmental action to be taken.
3. Debarred the respondent from being a part of any committee of the college for a period of one year for the academic session 2024-25.
4. Increasing the tenure of probation of the Respondent by 6 months.
5. The compensation payable on the basis of mental trauma, pain, suffering and distress and the medical expenses incurred by the victim for the psychiatric treatment, if applicable under University Grant Commission (prevention, prohibition and Redressal of Sexual Harassment of Women Employees and Students in higher Educational Institutions) Regulation 2015, under Sec10(3) (a) and (c).

After due deliberations with the Complainant and the respondent in the presence of the ICC Convener, and the Lawyer (ICC, Member) it was decided that:-

1. All the documents related to ICC matter will be shared with both the complainant and respondent by Monday August 5, 2024.
2. Both parties will have 10 days to share their observations.
3. Observations of Complainant and Respondent will be shared with the ICC.
