**Terms and Conditions:**

Name of work: Annual Cultural Festival PHOENIX'26 of Motilal Nehru College, University of Delhi.

Documents to be submitted with tender:

1. Self-Attested copy of PAN Card and GST Registration Certificate.
2. Self-Attested copy of the confirmed availability conveyed by the star-artist whom the bidder proposes to arrange for performance at PHOENIX'26.
3. Bid should be submitted for separate stars and it will be treated as one tender and need to pay EMD at once. No additional star is allowed. Earnest money deposit (EMD) for an amount of Rs. 30,000 in the form of Demand Draft/Pay Order issued by a Scheduled Bank in favour of the Principal, Motilal Nehru College.
4. An undertaking (self-certificate) that the agency hasn't been blacklisted by a Central/State/UT Government Institutions and there has been no litigation with any Government department on account of IT services.
5. Please quote for artist fee including their stay, travel, food and technical requirements. Artists should perform Live for atleast 90 minutes on stage, failing which the payment for the artist shall not be made.
6. Bid should be submitted for separate stars and it will be treated as one tender and need to pay tender money and EMD at once.
7. EMD Exemption for MSME:  
Micro and Small Enterprises (MSEs) registered under the Udyam Registration Portal of the Ministry of Micro, Small and Medium Enterprises shall be exempted from submission of Earnest Money Deposit (EMD), subject to submission of a valid Udyam Registration Certificate and provided that the services/items quoted in the tender are covered under their registered category. The bidder must attach a self-attested copy of the valid Udyam Registration Certificate along with the bid to claim the EMD exemption.

**Other Terms and Conditions:**

The quoted rates shall remain same throughout the tenure of the contract and no revision is permissible for any reason.


1. No branding of any third party shall be done on head ramp or fascia except college. College reserves the right to reschedule or cancel the event and no compensation shall be entertained in such circumstances.
2. Any tender with incomplete information or quotes will not be accepted under any circumstances.
3. The bidder has to arrange one Star artist after due consultation with and confirmation from the Organizing Committee of PHOENIX'26. For the purpose of evaluation of Financial Bids, the price/cost as quoted by the bidder and the acceptability and reputation/standing of the artist would be an important consideration in the final selection of the bidder.

4. The rates will be inclusive of all taxes, fee, levies, etc. and any revision in the statutory tazes, fees, etc.
5. If the agency fails to provide the services to the satisfaction of the Organizing Committee, such as inferior quality of service, failing in providing the mentioned services in part or in full, College can impose appropriate penalty in such case decision of the Principal, Motilal Nehru College shall be final and binding on the bidder/contractor.
6. Electricity for the scope of work shall be provided by the Motilal Nehru College free of cost. However, sufficient Power Back-up shall be arranged by the Event Manager. The Event Manager will be solely responsible for the connecting cables and other connecting devices from the main supply to the respective event venues. All the necessary safety precautions shall be taken while providing services by the service provider.
7. All installations/equipment/tentage/stage/sound and light equipment shall be made functional starting 9 am on the first day of the PHOENIX'26 and should be available for use up to 8:00 pm.
8. The organizing committee and the institute administration shall not be responsible for any damage to goods.
9. The payment will be made to the Firm only on the Bank Account registered in their name maintained in India by way or NIFT/RTGS/DD after deduction of all kind of the TDS as applicable.
10. The quoted price shall be INCLUSIVE of GST and all other taxes (if applicable).

**Special Terms and Conditions:**

1. The whole event is meant for Motilal Nehru College students, faculty, officers, staff of Motilal Nehru College or other guests invited by Motilal Nehru College authorities only.
2. The event manager can neither sell tickets nor issue passes to anyone and nor can he extent any sort of invitation to anyone whosoever for any of the events being organized at Motilal Nehru College campus during the contract period.
3. The erection of hoardings, banners, flexes etc. inside the College campus will be carried out in consultation with the Festival Organizing Committee.
4. The event manager is advised to visit the campus before quoting the rates to assess the scope of work and site conditions.
5. During two days of the festival expected foot fall is of 8,000 people. The arrangement for adequate manpower and other resources, besides crowd management and orderly conduct of the events shall be the responsibility of the Event Manager (contractor).
6. Neither direct advertisements nor proxy advertisements for any liquor or tobacco product or any other banned item shall be allowed inside the College Campus. Besides this, hoardings, banners or flexes containing obscene/vulgar/defamatory content shall also not be allowed for display.
7. Stage setup, music and sound equipment and backdrop as per requirements of the artist and decoration will be the complete responsibility of the Event Manager.
8. Boarding, lodging & transportation, food/refreshments of ARTISTS to be provided by the event manager.
9. No songs will be played in any case emphasizing on any particular religion, region or caste. Failing to comply would face a strict action from the College Administration.

**Special Note:** The Principal and the Festival Organizing Committee holds absolute right to amend/add/modify/drop/delete/cancel the bid or any of the clauses of this tender and terms and conditions, as they deem fit without assigning any reasons.
